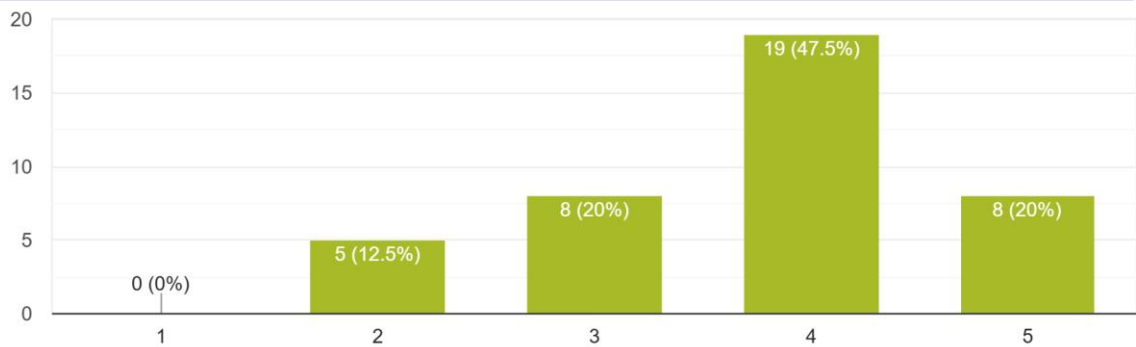

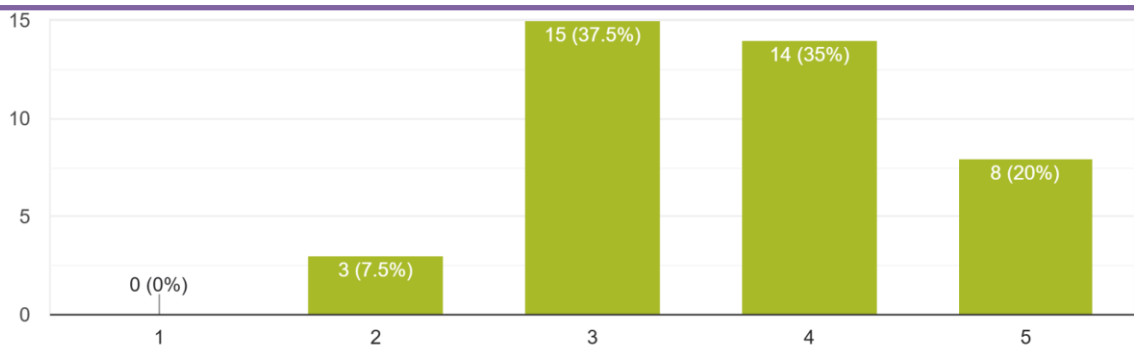

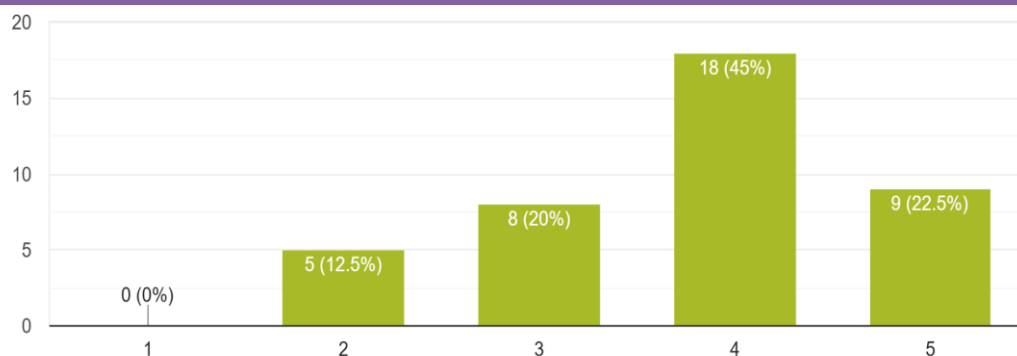

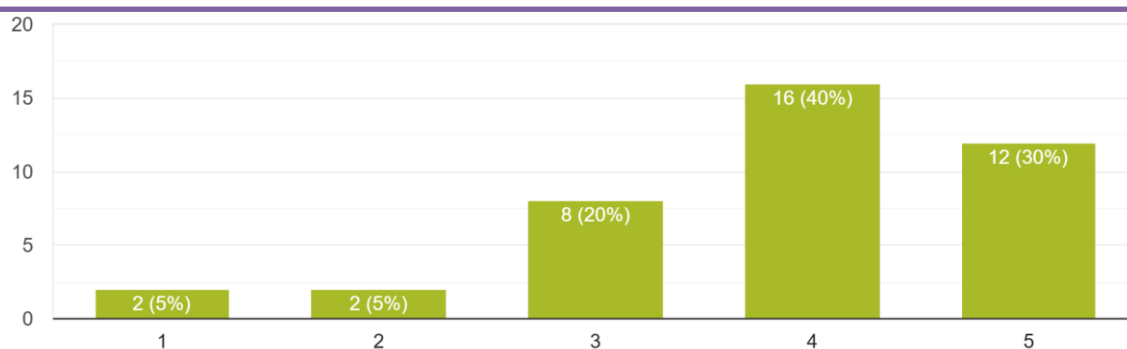

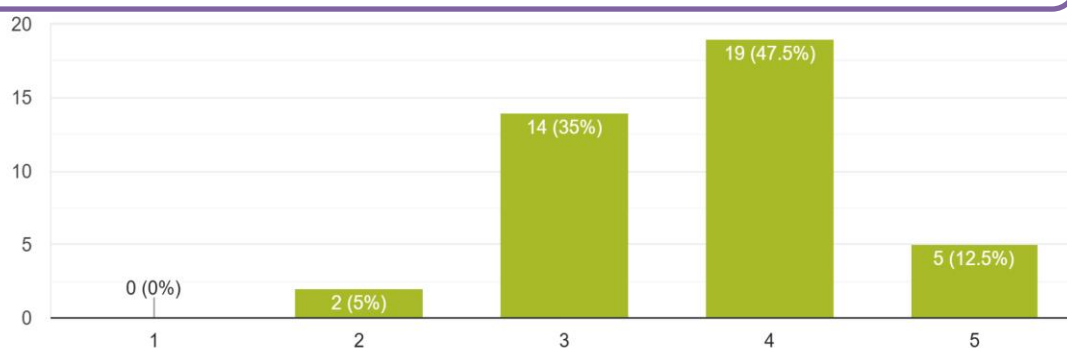

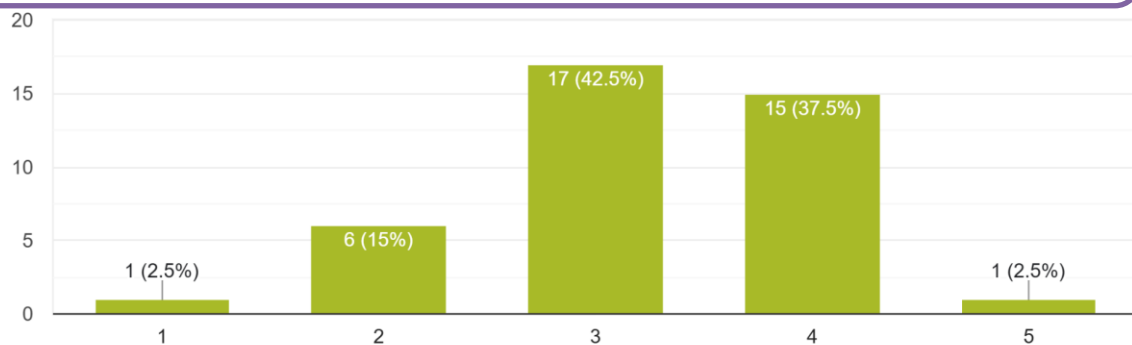

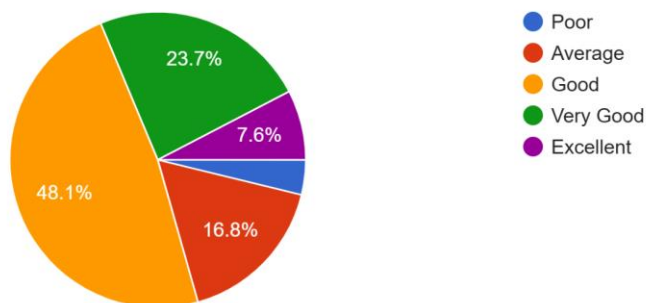

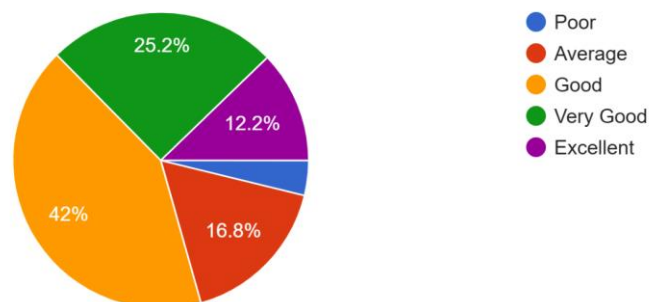
DEPTH OF THE CURRICULUM



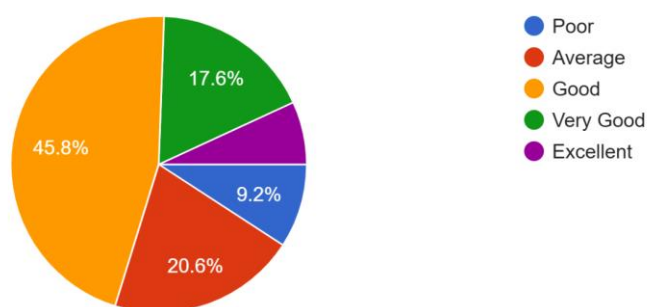
AVAILABILITY OF INSTRUCTIONAL HOUR



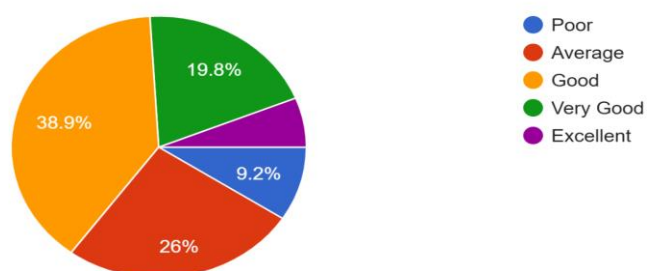

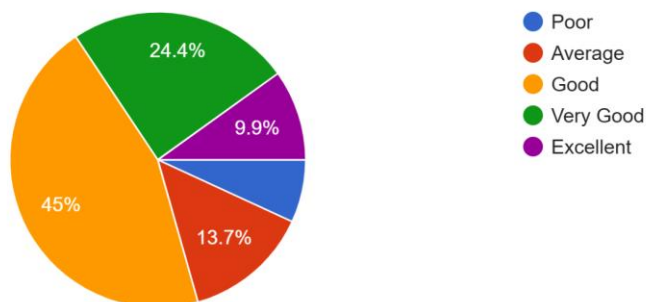

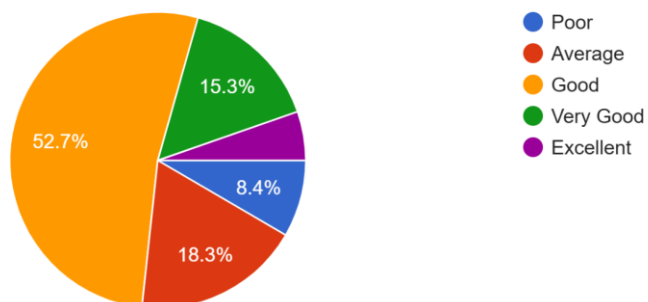

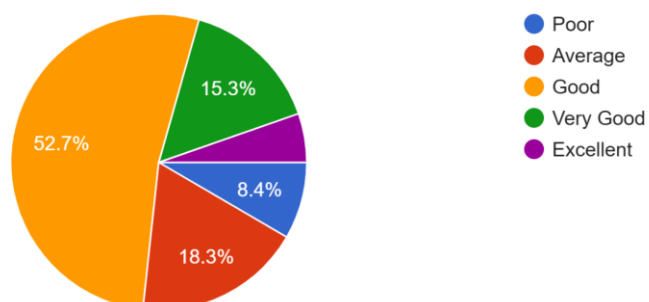

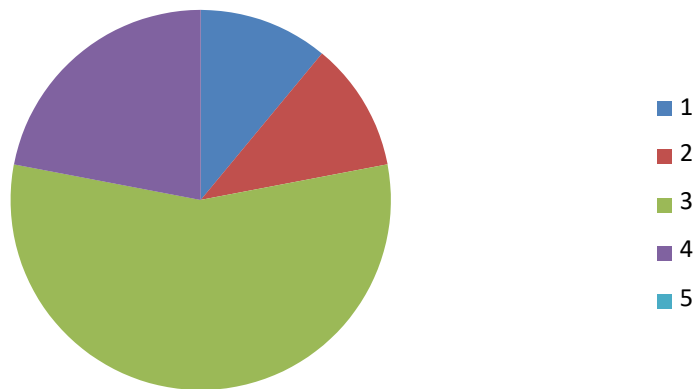

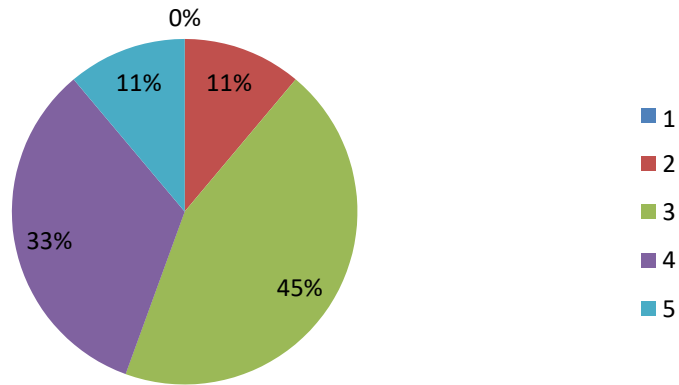

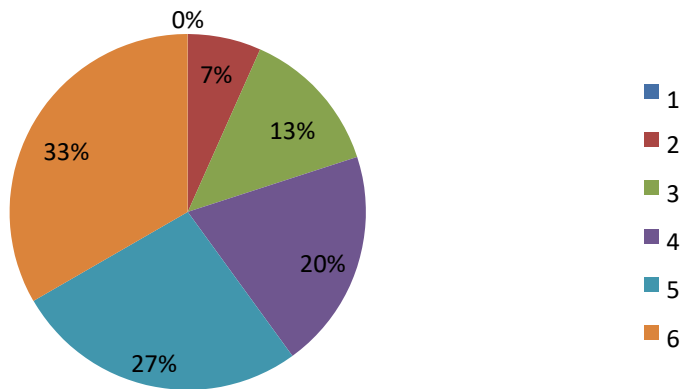
